EXECUTIVE SUMMARY

Comprehensive Health Research Centre (CHRC) is a new, national centre of excellence providing a unifying environment for innovation and education in public health, lifestyles, nursing, rehabilitation, and clinical research.

CHRC gathered in 2020 a total of 166 integrated PhD Researchers, 85 PhD students, and 41 integrated non-PhD researchers and technicians. CHRC grew in the number of people involved, presenting an increase of 33% in integrated PhD researchers and 42% in PhD students.

Regarding scientific impact indicators in 2020, CHRC presented a total of 539 publications. About half of this number (262) are scientific articles published in high-impact journals. The CHRC PhD integrated researchers are involved, as principal investigators or participants, in 124 national and international projects, equivalent globally to almost 42M €.

Integrated members of the CHRC are involved with 48 networks and working groups, as well as 29 activities initiatives, actions, and activities in collaboration with international consortia, at European and global levels, related to all CHRC thematic lines. The effort to transfer scientific knowledge is translated in 6 patents and 9 prototypes and software.

In 2020, CHRC researchers participated as active members in 104 civil societies or scientific organizations, carried out 64 activities that contribute to disseminating scientific knowledge in civil society, and 60 provided services to the community.

CHRC has defined its strategy around three main strings: platforms for technical and administrative assistance, platforms for scientific support and training, and annual structural initiatives, and made important advances in all, nevertheless, the pandemic crisis for SARS-CoV-2, which blasted globally and greatly affected research and strategic plans, as well as had a significant impact in pursuing the objectives of setting up a structure solid research support. These facts also obstructed the expected financial execution.

1. STRATEGY DEFINITION AND EXECUTION

CHRC is committed to producing innovative, preventive, and treatment strategies and healthcare delivery based on robust evidence to improve individual and public health, around five principal fields: I) Health promotion, II) Lifestyles in healthcare, III) High burden and high mortality diseases, IV) Health policies and healthcare services research, and V) Health innovation.

CHRC was established to capacitate researchers and give them all means necessary to provide the best multidisciplinary environment to achieve the best outcomes. To pursue this broad objective, the CHRC strategy is grounded on three strings:

1st) Platforms for technical and administrative assistance

- **Executive and management office** to manage day-to-day operations, coordinate and manage technical and administrative teams; control costs; prepare regular performance reports; supervise communication and dissemination initiatives and implement best management practices; develop and disseminate the Unit's strategy and mission to all members and technical and administrative teams, and promote fundraising;
- **Funding office** to boost researchers fundraising by helping them to know and prepare proposals for applying for national, international, and structural funding;
- **Communication office** services towards outside, but also to ensure the communication and dissemination of information between the management units of CHRC.

2nd) Platforms for scientific support and training

- **Training and education unit** that aims to support the creation of teaching and advanced training opportunities for researchers and students at the CHRC;
- **Data analysis office** to assist with quantitative and qualitative methods of data analysis;

- **Biobank** structure and service as essential infrastructure to support biomedical research, addressing all its facets, such as prevention, diagnosis, treatment, and monitoring of specific characteristics of a disease.

3rd) Annual structural initiatives

- **CHRC Research Grants** is a yearly initiative awarding collaborative and multidisciplinary projects, with a total endowment of 320,000 €;
- **CHRC Annual Summit** aims at enhancing communication between members and management units to boost and promote clinical, public health, and health services research of a collaborative and multidisciplinary character;
- **Financial support for scientific publication**, stimulating the scientific production of CHRC member researchers;
- **CHRC PhD scholarships (15 positions)** within CHRC management institutions and thematic lines, funded by FCT, IP.

CHRC started in January 2020. In March of the same year, the pandemic crisis for SARS-CoV-2 blasted globally and greatly affected research and strategic plans, as well as had a significant impact in pursuing the objectives of setting up a structure solid research support. These facts also obstructed the expected financial execution.

Regarding the first string of platforms for technical and administrative assistance:

- In August 2020, the employment contract for the Executive Director, responsible for the Executive and management office, was established.
- During 2020, tenders were prepared for 3 positions in the funding office, 1 position for senior communication technician and the entire procedure to acquire specialized website construction and communication strategy services began to be prepared. Due to bureaucratic barriers, procedures were not concluded in 2020.

Considering the second strategic string - platforms for scientific support and training:

- The implementation kick-off of the biobank took place in September 2020, with the beginning of the Researcher's employment contract responsible for the coordination and implementation of the CHRC Biobank.
- In addition, equipment, software, and consumables, necessary for the assembly and operation of the Biobank were purchased, and negotiations

began for the processing and transportation of sample collections from CHRC researchers located in other institutions.

- In November 2020, started one Principal Investigator's contract to execute, regularly, research and development activities and all other scientific and technical activities within the mission of the CHCR R&D Unit.
- Also, during this year, tenders were prepared for 2 post-doc positions for the data analysis methods office.

About the third strategic string - annual structural initiatives:

- Two collaborative and multidisciplinary projects proposed by integrated members of the CHRC were awarded the amount of € 80,000 in 2020. The projects will be carried out within 24 months following the award.
- CHRC summit was held for 2 days, which brought together about 120 participants, members of the CHRC, simultaneously, and offered 5 conferences, 4 round tables, 20 presentations of CHRC projects. Because it was carried out remotely, given the pandemic situation, it only involved the expense of the webinar platform.
- Ten out of the 15 PhD scholarship positions were awarded, whose contracts started between September and November 2020 and are directly supported by FCT.

Up to December 2020, CHRC gathered a total of 166 integrated PhD Researchers, 85 PhD students, and 41 integrated non-PhD researchers and technicians. In addition, as a result of the potential and work developed within CHRC, 72 researchers, integrated in other national research units, joined the CHRC as collaborating members.

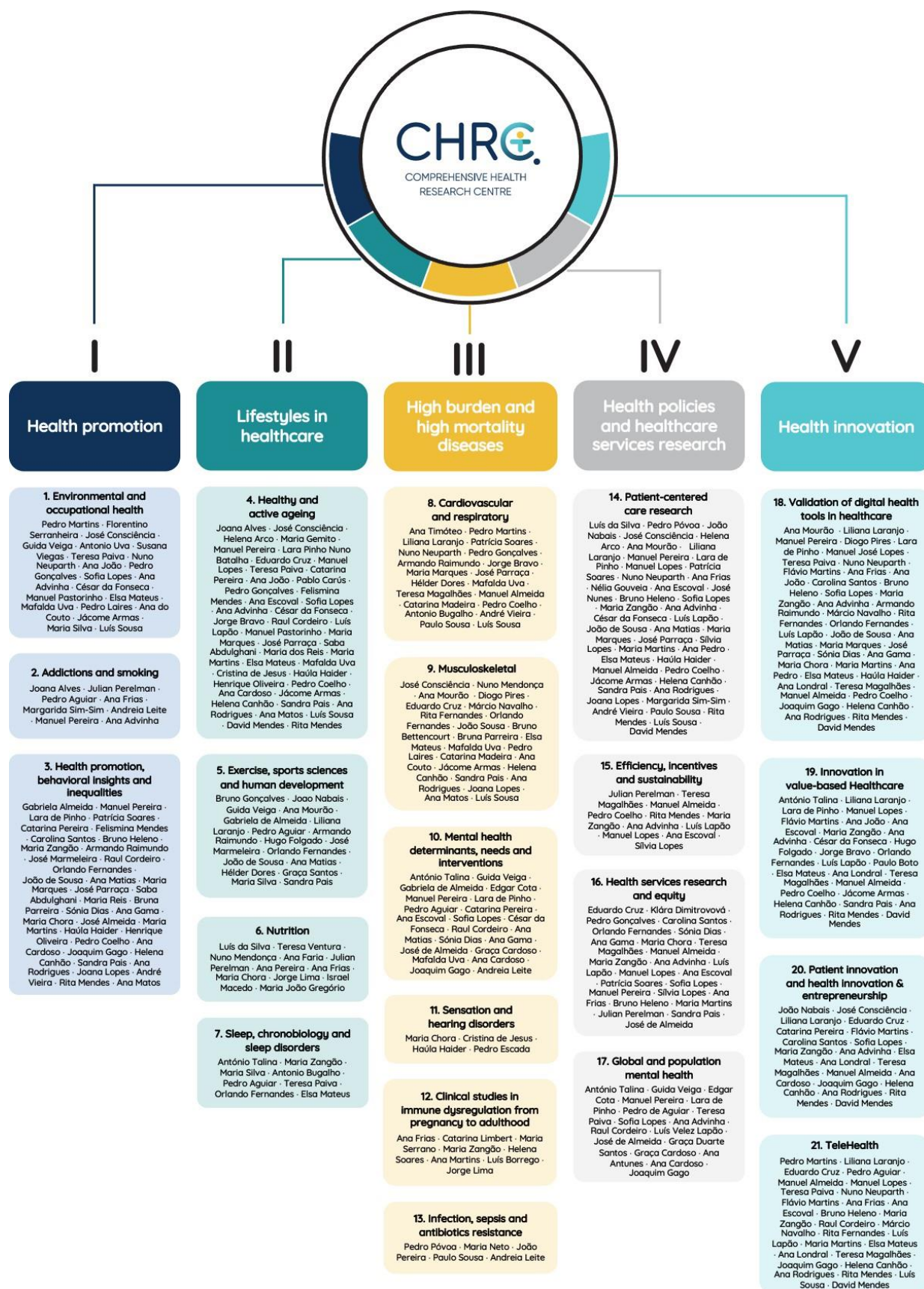
In January 2020, the official starting date of the CHRC, members numbers were as follows: 125 integrated PhD researchers, 60 PhD students, 48 integrated non-PhD researchers and technicians, and 47 collaborating members.

A comparison exercise shows that, in 2020, CHRC grew in number of people involved, presenting an increase of 33% in integrated PhD researchers and 42% in the number of PhD students.

3. SCIENTIFIC INDICATORS

3.1. Publications

In 2020, CHRC presented a total of 539 publications. About half of this number (262) corresponds to scientific articles published in high impact journals (Q1 or Q2 - SCOPUS index).

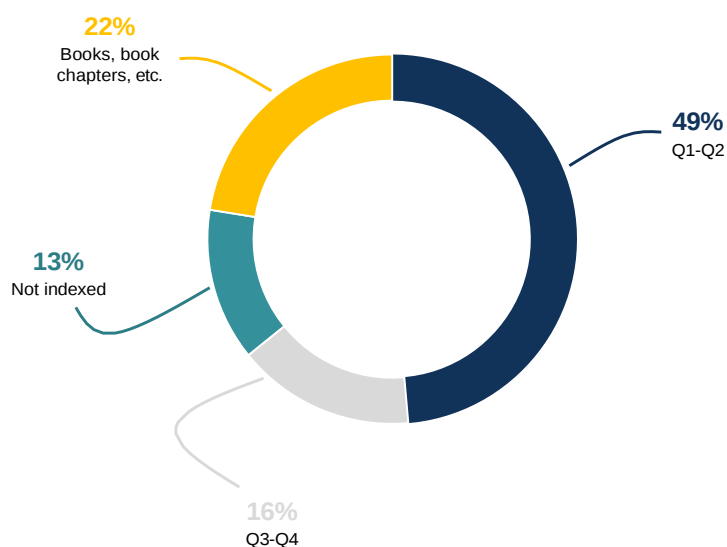
CHCR researchers published 84 Articles in peer-reviewed journals Q3 and Q4 (SCOPUS index), and 72 articles in other journals (not indexed). Regarding books, book chapters and other publications, CHRC registered 121 existences.

The thematic line that presents the greatest number of articles in scientific articles published in reference journals (Q1 or Q2) is TL III – High burden and high mortality diseases, followed by TL II – Lifestyles in healthcare.

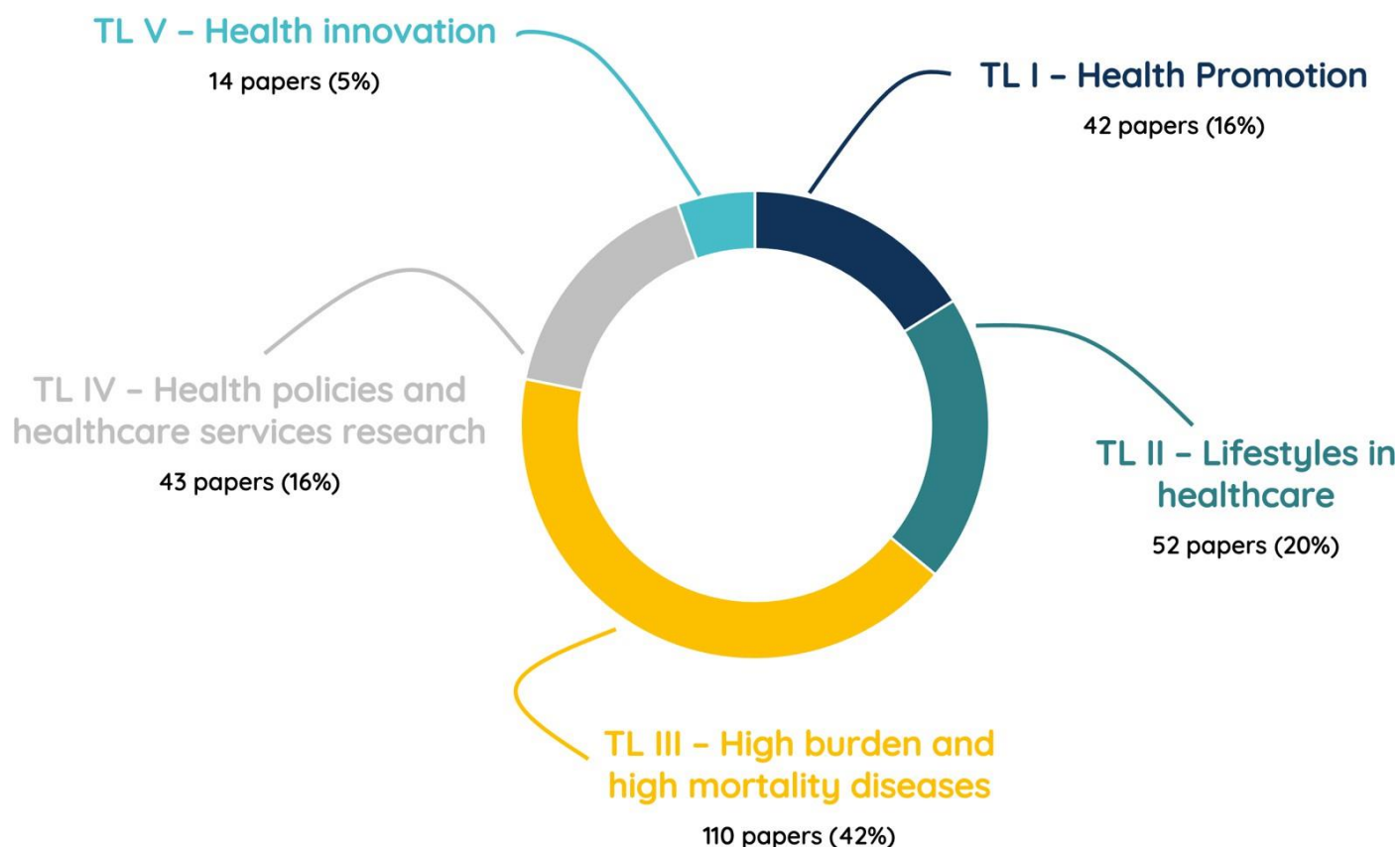

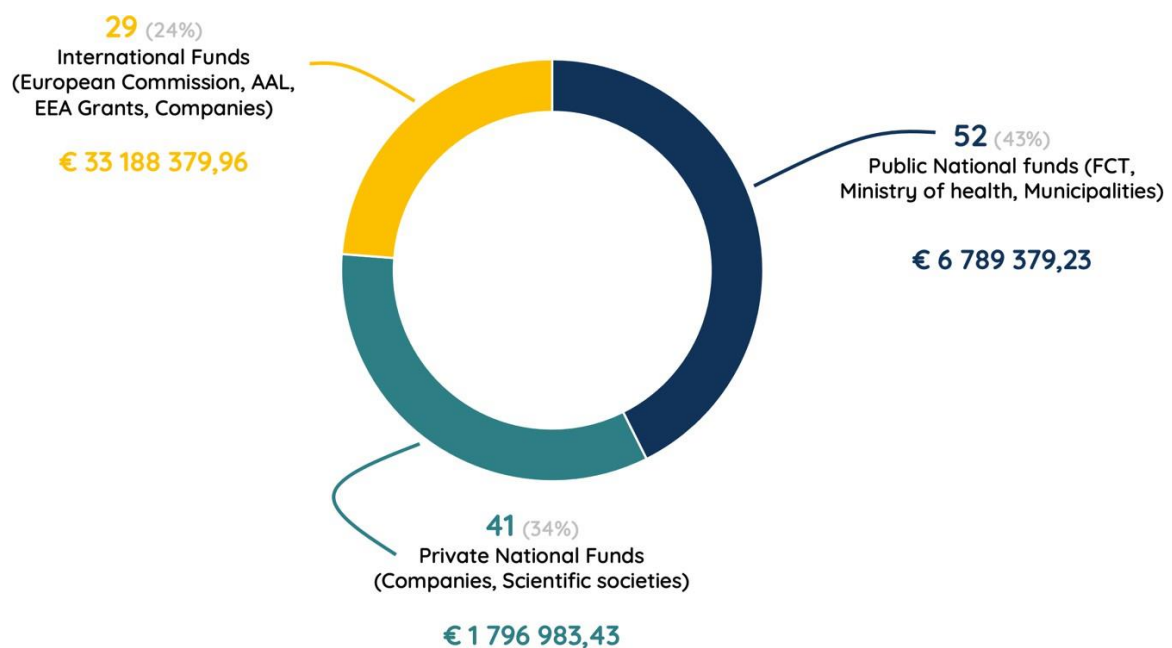

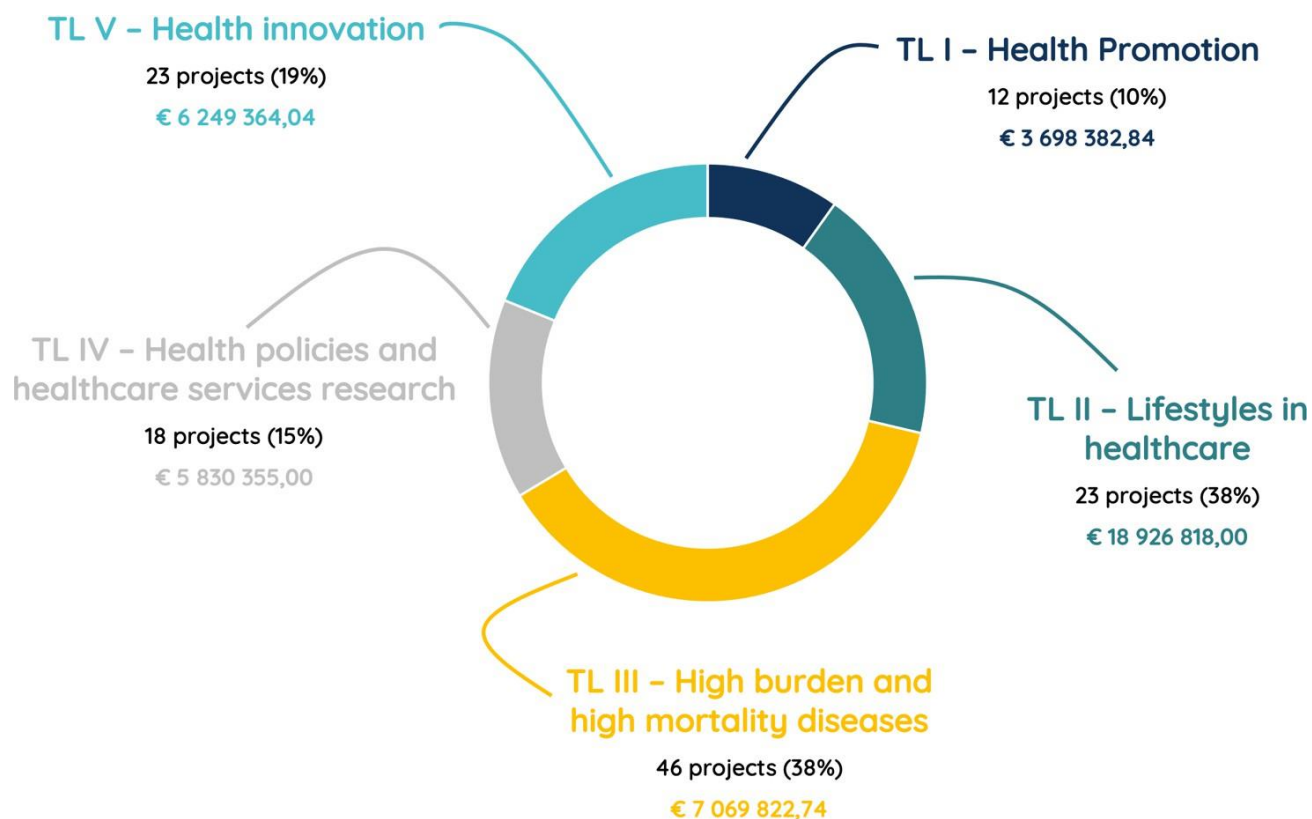
